Detainee map tracked to the previous residence of 'Amir al-Sharia, AKA Abu Shakir, [REDACTED] 'Amir lived on the second level of a two story home. The property had a large gate on the north side of the property for a car to pass through and a small pedestrian gate on the south side of the property. The stairs to the second level were located outside the residence on the south side. The stairs were black metal stairs that are visible from the street. Detainee used to go to 'Amir's residence to teach 'Amir the Sharia law. Detainee met 'Amir's son Shakir, 14 years old, while at 'Amir's residence. Detainee was last at the residence in June or July 2008. 'Amir told Detainee that 'Amir had moved to a new residence since Detainee's last visit and Detainee does not know the location of 'Amir's new residence. 'Amir moved near 'Amir's old residence because Detainee has picked 'Amir up in the same area.

Detainee map tracked to the former residence of Abu 'Ayah, [REDACTED] Abu 'Ayah moved out of the house approximately four months prior to Detainee's capture. A family from Baghdad moved into the residence and the house was subsequently raided by CF. [REDACTED]

Anmar, the former Wali of Mosul, is always with Abu Mahmud and Abu Mahir. Anmar was transferred to north Mosul after Anas took over as the Wali of Mosul. Anmar had a military role in the north. Abu Mahmud was the Wali of the north and Abu Mahir was the north Mosul administration Amir. Three days prior to Detainee's capture Mosul ISi absorbed ISi north. Abu Mahir went to work for Mosul administration. Abu Mahmud has either a security role or military role in Mosul and Anmar has yet to be assigned a position in Mosul.

Abu Zahra is an ISI military member who worked with Haydar al-Afiri. Abu Zahra was Haydar's driver and possibly Haydar's administration amir. Detainee last saw Abu Zahra on the day Haydar al-Afiri was killed. Abu Zahra was driving Haydar in the Suq al-Ma'ash Market at 1100. Detainee stopped Haydar and Abu Zahra and spoke to Haydar. Haydar had been transferred to ISI Jazirah and Detainee wanted to discuss the matter with Haydar. Haydar was transferred because CF was getting close to capturing Haydar and Haydar's face was well known. Haydar planned to go to the Jazirah area later in the day. Detainee was surprised to hear the following day that Haydar had been killed because Detainee thought Haydar had left the area. Abu Zahra does not have the necessary experience to assume Haydar's position as west side military amir.

Detainee has heard from members of ISI military that Sabti brings weapons into Mosul from the Jazirah area. Detainee does not know where weapons are stored in Mosul. Sabti and 'Umar Hadid are responsible for weapons.

Bilal is the amir of the "Industry Group". The Industry group manufactures VBIEDs. Bilal is subordinate to Abu Ibrahim the ISI military amir of Mosul. Detainee does not know where the VBIEDs are manufactured or where the group procures the material to construct the VBIEDs.
