Detainee met with Jar Allah on two occasions in the market area of Hay al-Sumar. 'Amir Sharia was complaining that Jar Allah was interfering with 'Amir's position as the Sharia 'Amir of the left side of Mosul. Detainee planned to order Jar to stop meddling in 'Amir's business and that Abu Ibrahim, the ISi military amir of Mosul, planned to move Jar into a military role. When Detainee met with Jar Detainee greeted Jar and then listened as Jar talked and talked. Jar also worked his worry beads furiously. Detainee just wanted to end the meeting because Detainee felt intimidated by Jar. Detainee decided to let Abu Ibrahim confront Jar. Once Abu Ibrahim moved Jar to a military role the problem with Jar's meddling in 'Amir's affairs would be solved. Jar and Anas, the Wali of Mosul, have a strong relationship. Jar and Anas worked together in a different ISi area of operation, either Jazirah or an area south of Mosul. 'Amir Sharia has more information regarding Jar better than Detainee or Abu Salim [REDACTED]

Sadiq, AKA Abu 'Abdallah was at the Bedouin camp with Abu Sara, AKA Abu Qaswarah. Detainee has also seen Sadiq at the Suq al-Ma'ash Market with Abu Arab. Detainee stopped and greeted Abu Arab and Sadiq. Abu Arab and Sadiq were shopping for jackets at the market and asked Detainee to request funds from Harith to purchase the jackets. Detainee made the request to Harith and obtained 200 USO for the purchase of the jackets. Detainee contacted Abu Arab a few days later and gave Abu Arab the money. Detainee does not know what Sadiq's position is in the ISi but Sadiq is with Abu Qaswarah often. Sadiq also accompanied 'Abbas to the rendezvous at the hill on Detainee's first trip to Abu Qaswarah's Bedouin camp. Detainee provided the following physical description of Sadiq:

Hakim, AKA Abu Sara, the Farqan media Amir, gave Detainee a verbal message to take to Abu Qaswarah on Detainee's second trip to meet with Abu Qaswarah. Hakim had Abu Shahad's car and wanted to know if he (Hakim) could sell the car and purchase a new one. Detainee does not know how Hakim came into possession of Abu Shahad's car. Detainee gave the message to Abu Qaswarah and Abu Qaswarah told Detainee to tell Hakim that the decision was up to Hakim. Detainee relayed the message to Hakim upon returning to Mosul.

Hakim is not a member of the Mosul ISI structure. The Farqan Media structure is independent of Mosul ISI media. Hakim was the ISI amir of media in Mosul when Detainee became a member of the ISI in July 2007. Khalid became the ISI media amir two to three months prior to capture and Hakim moved to the Farqan network.
