Content of Request

To the brother, the wali of al-Raqqah, may God preserve you. Peace be upon you, God’s mercy and His blessings. And as to what follows:

When we were in a ribat shift at one of the checkpoints, a resident car came and the owner of the car identified himself as an arms dealer. We stopped him because he did not have any identification or car papers.

And then, our emir, Abu Nidal came and told us: “Do not let him go until someone from the Supplying [Office] comes to identify him.” Where the owner of the car had claimed that he was working with the Supplying, but without providing proof. Then, brother Abul-Aktham al-Ni’imi, who supervises the checkpoints, came and allowed him to pass without Abu Nidal’s permission, knowing that Abu Nidal confirmed that he would not be allowed to cross before someone came to vouch for him or provide evidence.

Abu al-Aktham said to me: “I am the emir of checkpoints, and you must listen and obey. Do not care about Abu Nidal, and if you do not listen and obey, then I will raise your name to the wali.” He also said: “It is forbidden to shoot in the air at a speeding car. We inform you that many resident cars cross and we do not stop them because everyone in this car are brothers.”

Is it necessary to verify this matter, and we inform you that the management of the checkpoints is under the control of the Operations Room.

And may God reward you the best.
