As for his words, which he said to me, "You, the police are soft," these words are according to my analysis based on what I think he meant to say, but he did not say them literally. However, he said, "soft and any brother can humiliate you in the station."

As for the issue of preparing himself for the emirate, he told me, "I will go to the wali and see how he will settle the case." He said that after I asked him whether he would become the emir of the Public Police of the wilayah.

He said to me, "You are soft with the brothers." I said to him, "What do you mean by soft?" He said, "Any brother who enters the station can humiliate you."

He came from the northern district, punished, and Abu 'Abdul-Rahman al-Furati, al-Furati's cousin, was in charge of patrols in the north. And when he moved to the Public Police on patrols in the city, and when they wanted to hand over the leadership to him, he said to the brothers, "I deal with the brothers the same way I deal with women I have. They need a tough man. (Abu Ahmed, Abu Madyan) are witnesses to this phrase when he said it.

The case of Qaswarah. Brother Abu Sayyaf al-Sarawi asked me to submit it because he requested a lift and it did not come. He said to me, "Lift it and he will raise it as well." [The original paragraph in Arabic is confusing and doesn't make sense]
