Content of Request

To the brother, the wali of al-Raqqah, may God grant him steadfastness. Peace be upon you, God’s mercy and His blessings. And as to what follows:
 I am sister Umm Muhammad al-Ansariyah. I am 28 years old. I have 5 children and I’m with the Martyrs’ Office of Wilayat Raqqah.
 There was a problem between me and sister Umm Muhammad al-Tunisiyah regarding the martyrs’ card because I left it with her. They gave my compensation to someone else. And there was an argument between me and her and her daughter beat me. I went and complained to the Emir of the Martyrs’ Office, called Abu Mahmud al-Shami. I told him about the negligence that had taken place and that my compensation was given to someone else and how they accused me of being a smoker.
 He said to me, “I will hire you, but do not complain and consider yourself an employee from the beginning of this month.” But I told him that I didn’t want that. I want to proceed with my complaint and I can’t work. He replied, “You are taking money that is not your right, and the exception for your compensation will be cancelled.” I am in the city of al-Bab, and the exception was granted to me and my children, at the time, by the wali, Abu Ayyub al-Ansari.
 Brother Abu Mahmoud said, “If you go to the judge, he will flog you a hundred lashes.”
 I came two days ago to complain to the brothers in the wali’s office, but nothing happened.
 And I say to the wali brother that those in charge of the Martyrs’ Center should fear God while dealing with the wives of the martyrs.
 Please help because I have not yet received my compensation.
