#### Content of Request

To the brother, the wali of al-Raqqah, may God preserve you. Peace be upon you, God’s mercy and His blessings. And as to what follows:

I’m filing a complaint against the General Hospital regarding my father, who was a 70-year-old heart patient. On Thursday, after his condition deteriorated, he was hospitalized and he was in a coma. On Saturday afternoon, my father passed away - may God have mercy on him. Then I asked the brother in charge of the refrigerator to keep my father in the refrigerator until my brothers come from ribat, and it was expected that they would come two days after his death. So we put the corpse in the refrigerator, and on the second day I went back with my brother Abu Hussein and confirmed to the hospital administrator Abul-Ayham in order to keep him in the refrigerator for another day. The brother agreed, but he said to me, “Your father was in the Popular Committees,” and he winked at me, so I understood the possibility of a security issue, so I left him and went. On the second day (Monday) I went to collect my father’s body, but I could not find it. They searched for it and did not find it. So I went back to the administrator, Abul-Ayham, and told him. He called through the wireless device and the landline, so a brother named Abu ‘Abdul-Hamid came. I waited for him at the refrigerator, and after making sure it was brother Abu ‘Abdul-Hamid, I was surprised that my father’s body was not there and that it was dumped in an area outside the city in a garbage area, which is an area for the apostates. So I went with brother Abu ‘Abdul-Hamid (the guide for where my father’s body had been thrown) and brother Abu Abdullah and Abu Suleiman, the refrigerator official, to the area where the corpse was thrown. We took it out, brought it to the hospital, and washed it. The brothers gave us a ride to Albu ‘Asi, where my father was buried. After finishing the funeral ceremony, I came back to you to submit this complaint...[The author draw an arrow here to indicate page continuation]
