**Subject/ A Grievance**

I, Saddam Abdullah Salih, with the kunyah of Abu Rasal, am 40 years old. I submit to you my grievance. I suffer from diseases mentioned in the medical report attached. I would like to inform you that I requested my transfer outside of the camp due to injury (in al-Kawir battle) and documented in the medical reports. After signing the transfer order, by the party that I'm transferred from and the party that I'm transferred to, the military administration responded by rejecting it. During that period, which is close to four months, I was sick and I was seen by the Diwan of Zakat and Charity in [Mosul's] Left Side according to the request of the emir of Diwan of Zakat. The emir of the Diwan of Zakat and Charity of the Left Side, Abu Zaid, used to say to me, "Have patience until I finish your memo." Four months later, he handed me the memo and it has become clear that the military administration has not approved it. The emir of the Diwan of Zakat said to me, "Bring me another memo." So, I went to sector, in which I used to work, and they said to me, "We don't have your name. Go to the Military Police." Then when I went to the Military Police, they said to me, "Go and make a new bay'ah." For your information, I'm a veteran brother since the year 2005. I had previously suffered from persecution and arrest by the apostates, and as a result, I suffered from slipping of the vertebrae in the prison. Please accept to transfer me or send me back to the sector I used to work in before.
